To All Members and Clearing Banks,

We are pleased to inform that India International Depository IFSC Ltd. (IIDI) has empanelled an additional vault operated by **M/s Sequel Logistics Private Limited in Madras Export Processing Zone (MEPZ)-SEZ, Chennai.**

Effective August 19, 2025, all the Gold and Silver **T+0 Chennai** Contracts currently traded on IIBX and delivered through **Brinks India Private Limited at J. Matadee Free Trade Warehousing Zone (FTWZ), Chennai**, will also be deliverable through this new vault operated by **M/s Sequel Logistics Private Limited in Madras Export Processing Zone (MEPZ)-SEZ, Chennai**. These contracts will henceforth be referred to as **“Chennai Contracts”** in the IIBX trading terminal and can be delivered from any of the above Chennai vaults.

Accordingly, Chennai will now have two vaults available for market participants to facilitate deliveries. Qualified Suppliers will have the advantage of supplying to both Chennai vaults, in addition to the vaults at GIFT IFSC. All other terms of Trading and Delivery process for the T+0 contracts remain unchanged.

***Note:**

1. The first 3 characters of SDV ID denote the Vault Provider i.e. 101 for Brinks and 100 for Sequel.
2. The next 5 characters of SDV ID denote the Location i.e. 00044 denote Chennai.
3. The last 2 characters of SDV ID denote the vault number of the Vault provider i.e. if the particular vault provider has multiple vaults in the location, the last 2 characters will be 01, 02 and so on.
